Publications Usage Permission Details

1. In most cases, a minimum processing fee of \$25 will be charged for approved permission requests.
 - a. The processing fee will count toward any additional fee necessary for usage permission and will be included in the total fee listed on the form.
 - b. Not every permission request will have an additional fee.
 - c. No fee will be charged if the permission request is denied.
2. Liguori Publications is unable to grant permission requests for out-of-print works.
3. The entire form must be filled out in order to process the request and assess the fee.
 - a. This includes all fields with the contact information for the requestor, all fields describing the Work and portion of Work to be used, and all fields regarding the intended use and range of distribution.
 - b. The only fields to be left blank upon submission are those highlighted in red at the top of the form regarding the fee and permission grant status, to be filled out by a Liguori representative.
4. Payment should only be made after the fee is assessed by a Liguori representative and the permission request is approved.

 - a. The citation should include the following information: Author, Name of Work, Publisher, Publication Year. Reprinted with permission from Liguori Publications, a ministry of the Redemptorists.
 - b. Example: Caryll Houselander, *The Way of the Cross* (Liguori, MO: Liguori Publications, 2002), 100. Reprinted with permission from Liguori Publications, a ministry of the Redemptorists.

PERMISSION TO REPRINT
